# a. Governing Law and Jurisdiction

Unless otherwise required by applicable law, these Terms shall be governed by and construed in accordance with the laws of Denmark, without regard to conflict-of-law principles.

For any legal claim, dispute, or controversy arising from or relating to these Terms, the Site, or Cambiotics' Services that is not subject to arbitration, you agree to submit to the exclusive jurisdiction of the courts located in Denmark. You expressly waive any right to challenge jurisdiction based on forum non conveniens or other similar doctrines.

The United Nations Convention on Contracts for the International Sale of Goods and the Uniform Computer Information Transactions Act (UCITA) are expressly excluded from these Terms.

# b. Arbitration Agreement

To the fullest extent permitted by law, any claim or dispute between you and Cambiotics arising out of or relating to these Terms, the Site, or any services or

products offered through the Site shall be resolved by final, binding arbitration under the rules of [Insert Arbitration Body].

- The arbitration shall take place in Denmark, unless both parties agree to an alternative venue or remote arbitration (e.g., online or by written submissions).
- The arbitrator's decision will be final and binding, and judgment on the arbitration award may be entered in any court with jurisdiction.
- Either party may seek injunctive relief in a court of competent jurisdiction for disputes involving intellectual property, unauthorized access, or misuse of the Site.

# c. Class Action and Jury Trial Waiver

- YOU WAIVE YOUR RIGHT TO A TRIAL BY JURY in any legal proceeding.

#### a. Modification of Terms
